FINANCIAL PARAMETER QUESTION:

We are in the process of developing a budget for our proposal and we cannot find in the RFP or any accompanying materials what the funding parameters are. Can you tell me the available funds for an award and/or the range of expected available funding?

RESPONSE:

The Counties have received recommendations from the Maryland State Office of Procurement to not provide specific amounts for funding parameters, particularly due to the late Fiscal Year 2023 release of the Mobile Response Stabilization Services RFP No. 20230201. With that being shared, the Maryland Department of Health, Behavioral Health Administration has allocated up to \$1,000,000 available for use beginning in Fiscal Year 2023, ending March 14, 2024.

The funding parameters for the remainder of Fiscal Year 2024, to June 30, 2024, would be contingent upon funding available through the Maryland Department of Health, Behavioral Health Administration, as would the funding parameters for Fiscal Year 2025 and Fiscal Year 2026. The requested RFP Funding Proposals will assist the Counties to work with the Maryland Department of Health, Behavioral Health Administration for ongoing funding of Mobile Crisis and Stabilization Services for the Counties.
